BEING SEISED of Case File No. 002/19-09-2007-ECCC/TC pursuant to the Decisions on Appeal Against the Closing Order by Ieng Sary, Ieng Thirith, Nuon Chea and Khieu Samphan,¹ rendered by the Pre-Trial Chamber on 13 January 2011;

HAVING RECEIVED the IENG Sary's expedited request for extension of time to file document and exhibit list for the first four trial topics (E106), filed on 15 July 2011;

NOTING Rule 39(4)(a) of the Internal Rules permitting a Chamber to extend time limits on its own motion;

FURTHER NOTING the communication of the Trial Chamber Senior Legal Officer of 20 July 2011 to the IENG Sary Defence, indicating that the Chamber would grant this request;

CONSIDERING that several significant filing deadlines for the IENG Sary Defence fall on 22 July 2011 and that no prejudice would result from the granting of this request;

GRANTS the IENG Sary Defence until Monday 08 August 2011 to file their document and exhibit list for the first four trial topics μ - μ
